Introduction

Programs are required to complete the “Clinical Practice Experiences” tool (or submit a document that provides evidence of the requirements) to demonstrate how clinical practice experiences prepare students to practice competently, safely and ethically across the lifespan and illness trajectories.

This tool is a snapshot of clinical practice placements and not intended to duplicate the curriculum map.

Tool Structure

There are two parts of the tool:

- Part A: Settings and Lifespan
- Part B: Increased Complexity and Independent Functioning

How to Complete Part A:

Settings and Lifespan

Part A of the Clinical Practice Experiences tool requires demonstration of:

- a variety of practice experiences across diverse settings; and
- a variety of practice experiences across the lifespan.

Part A of the Clinical Practice Experiences tool should be completed as outlined in the table on page 4.

Part A: Settings and Lifespan

How to Complete Part B:

Increased Complexity and Independent Functioning

Programs must provide a brief description of how client care, the complexity of patient or workload and student independent functioning is supported by clinical practice experiences. The description must include how the program addresses student progression towards:

- increased complexity of client care needs or workload complexity;
- increased complexity of patient assignments; and
- how expectations may vary in special care areas (e.g., Emergency Departments, Intensive Care Units).

Part B of the Clinical Practice Experiences tool is located on the second tab of the Microsoft Excel curriculum mapping document.
